This is to inform you that we have reviewed the inspection report of RIPL@GANJAM Training Center - TC146913. However, clarity is required for Training Centre - TC146913 for the Job Role of Organic Grower in the following aspect:

Demonstration area/Practical area:

The Demonstration area/Practical area required has not been adequately captured in the inspection report.

Organic grower: According to the SSC's standards, the centre should have a Practical/demonstration area in terms of cultivated/ cultivable field of 5000 sq. ft is required with availability of at least one irrigation source (Pond/Hand Pump/Well/ Canal); can be either owned or leased, lab is not required.

Kindly forward minimum 5 GPS enabled Photographs of Demonstration area with a declaration on Rs 10/- notarized stamp paper (if it is leased type) together with the copy of arrangement / tie-up with the facility provider on the provider's letterhead signed by the provider's authorized signatory and in case it is owned, one notarized affidavit needs to be provided.

2. Trainers' Qualifications:

The qualification certificates of the Trainers have not been adequately captured in the inspection report.

Kindly share with us the relevant educational Qualification Certificates and Experience Certificate of the trainers with supporting documents like salary joining letter etc and a notarized affidavit stating that documents provided are genuine.
